1 Briefly describe the organization's mission: Acquiring and managing conservation lands. It owns 718 acres of conservation land in Spokane County, Washington. Organization coordinates land and trail stewardship efforts with adjacent State and County government land owners.

Expenses included purchase of native grass seed, and native tree seedlings to reseed a forest fire burned area, and miscellaneous supplies. Other nonprofit organizations donated seedlings and supplies. The organization maintains one trailhead including trash pickup and servicing dog bag dispensers. The organization coordinated with service projects sponsored by adult and youth groups throughout the year involving 120 participants. The organization put on education program including a nature/science day camp for fifth graders (200+ participants) at Camp Caro in the Natural area. The organization led a series of nature walks for the public throughout Dishman Hills involving 340 participants.

4b (Code:) (Expenses \$ 5806. including grants of \$) (Revenue \$) The organization publishes a monthly newsletter and maintains a website to promote land conservation in Spokane County. The newsletter publishes articles about natural history and current events of the ecology and natural areas of Dishman Hills area, Spokane County. The organization expanded its social media presence with its Facebook page and electronic alerts of hikes and activities. The organization maintained its member software to register participants in hikes and service activities on its website.

4c (Code:) (Expenses \$ 5806. including grants of \$) (Revenue \$) The organization's goal is to expand the amount of conservation lands located in the Dishman Hills urban area in Spokane County, WA. During the year 2014, the organization acquired 48 acres of conservation land adjoining or near the Dishman Hills Natural Area, including a 28-acre parcel on the west side and a 20-acre parcel to the south. The organization also acquired a foot trail easement through private property which connected properties owned by the organization.
