THIS YEAR FUNDS WERE USED TO PURCHASE 26 ACRES OF PRIME CONSERVATION LAND THAT IS AN EXTENSION OF THE EXISTING DISHMAN HILLS NATURAL RESOURCE CONSERVATION AREA. FUNDS WERE EXPENDED FOR STEWARDSHIP PROJECTS INCLUDING TRAIL MAINTANANCE, ECOLOGY RESTORATION, AND TRAILHEAD SERVICING. THE CONSERVANCY RAN AN EDUCATIONAL PROGRAM INCLUDING AN NATURE/FOREST DAY IN THE NATURAL AREA FOR ELEMENTARY SCHOOL STUDENTS (APPROX. 225). THE CONSERVANCY ALSO PROVIDED A SERIES OF GUIDED NATURE FOR THE PUBLIC INVOLVING 320 PARTICIPANTS.
