THE OVERALL CONSERVATION LAND IN THE DISHMAN HILLS INCLUDES OVER 2500 ACRES. OTHER PROJECTS INCLUDED TRAIL CONSTRUCTION AND MAINTENANCE, SIGNAGE, ECOLOGICAL RESTORATION, WEED CONTROL, AND TRAILHEAD IMPROVEMENTS. THE DHC CONDUCTS AN EDUCATION DAY PROGRAM FOR FIFTH GRADE CLASSES IN SEVERAL SCHOOL DISTRICTS (APPROXIMATELY 225 STUDENTS). THE DHC ALSO PROVIDES A SERIES OF NATURE WALKS INVOLVING 320 PARTICIPANTS.
